

LIABILITY WAIVER

I, the undersigned, hereby assume any and all risk for myself, my spouse, and all of my minor children associated with participation by any of us in any and all activities on or in any property, building, and/or facility owned, leased and/or operated by Country Fire, LLC ("Country Fire"), including, without limitation, volleyball practices and games, and any related activities and other sports and physical activities, and any pre or post game or practice events, gatherings or social functions (collectively, "Activities"), including but not limited to volleyball and any other outings and events. I fully release, hold harmless, and discharge Country Fire, all of its affiliates, and all of their respective owners, officers, managers, employees and agents (together with Country Fire, collectively the "Releasees") from any and all liabilities, damages, claims and causes of action for injuries, damages or losses of any kind, **including, without limitation, negligence by any Releasee**, sustained during any and all such Activities associated with Country Fire or otherwise.

I acknowledge, agree and represent that I understand the nature of volleyball and other sports and Activities, and that myself and any of my minor children participating in such Activities are qualified, in good health and in proper physical condition and do not suffer from any heart, lung or other medical conditions or diseases that might in any way hinder or prevent me or them from fully participating in volleyball or other Activities, or make me or them more susceptible to injury or harm while participating. I further agree and warrant that if at any time any of us believe conditions to be unsafe, we will immediately discontinue further participation in the Activity and notify Country Fire.

I fully understand that volleyball and other Activities involve risk and dangers of serious bodily injury, including permanent disability, paralysis, and even death ("Risk"); I fully understand these Risks and dangers may be caused by me or my spouse or children's own actions or inactions, the actions or inactions of others participating in the Activities, the condition in which volleyball and other Activities take place, or the actions, inactions, or negligence of the Releasees. I fully understand there may be other risks and losses either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and all responsibility for losses, injuries, costs, and damages I incur as a result of any of our participation in volleyball and other Activities, or caused or alleged to be caused in whole or in part by the Activities, the negligence of any Releasees, or otherwise related to or arising from any Activities or any consumption of food or beverages, including alcoholic beverages, in connection with such Activities. I hereby waive and release Country Fire from, and hold Country Fire harmless from, any and all such risks, injuries, losses, damages and claims, and I further agree that if I, my spouse, or my children, or anyone on behalf of any of us, makes a claim against any of the Releasees, we will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, losses, liabilities, damages, or cost which any such Releasee may incur as a result of such claim. I have read this agreement, fully understand its terms, and have signed it freely and without inducement or insurance of any nature and intended to be a complete and unconditional release of all liabilities.
